**Subject:** 2026 Governmental Accounting and Auditing Update

I am pleased to announce that on May 13 and 14, 2026, the Office of the State Controller will host 2026 Governmental Accounting and Auditing Update for Chief Fiscal Officers and agency designated representatives. This virtual conference will provide an update on the recent activities of the Governmental Accounting Standards Board (GASB) and a Governmental Auditing update. For the first time, this year's conference will include an Ethics Update designed to satisfy the State CPA Board's Ethics CPE requirement [21 NCAC 08G.0401 Professional Ethics and Conduct CPE]. Attendance will qualify for up to 8 hours of CPE credit, including 2 hours of ethics content. The course description is attached for your review. Please register as soon as possible, as the **registration deadline is Friday, May 8, 2026. Payments must be made on or before this date.** After this date, no requests for refunds will be considered. Payment can be made by credit card or electronic transfer in the North Carolina Financial System (NCFS) to the **Office of the State Controller**. Agencies should register attendees individually (with separate email addresses). Agencies using NCFS can submit one payment to cover all registration fees if all necessary notations have been made.

If you are paying by electronic transfer, please follow the instructions below:

- **NCFS agencies:** Use Supplier ID 119133 (OSC) and use the IGO site number tied to the 1400 OSC Business Services Alternate Site Name. In the IC transfer Notes field, **you must include the following for proper processing:** full names of all attendees and reference 2026 Governmental Accounting Update. If this information is not included in the Notes field, the transfer will be rejected in NCFS.
- **Non-NCFS agencies paying through NCFS:** Use agency number 1400 for payment. In the NCFS Notes field, **you must include the following for proper processing:** full names of all attendees and reference 2026 Governmental Accounting Update. If this information is not included in the Notes field, the transfer will be rejected in NCFS.
